RESOLUTION AUTHORIZING EXECUTIVE DIRECTOR TO EXECUTE AND DELIVER A MEDICAL BENEFIT PLAN FOR LAND BANK EMPLOYEES

WHEREAS, Article 16 of the NY Not-for-Profit Law (the "Land Bank Act"), authorizes the Albany County Land Bank Corporation ("Land Bank") to employ and provide compensation for an executive director, a property manager, an executive assistant, and an attorney, and such other agents and employees as it may require, in order to carry out the purposes of the Land Bank; and

WHEREAS, under the Land Bank's by-laws, the Board of Directors shall have complete discretion, power and authority in the management and control of the business of the Corporation; and

WHEREAS, by Resolution 6-2014, the Land Bank hired an Executive Director who reports directly to the board and is charged with the responsibility of managing staff, controlling the organization's budget, and implementing the goals and mission of the Land Bank, and overseeing all of the activities of the Land Bank; and

WHEREAS, by Resolution 12-2014, the Land Bank delegated the Executive Director to serve as its hiring officer to solicit candidates and hire certain key personnel; and

WHEREAS, this Board now desires to authorize the Executive Director to execute and deliver a medical benefit plan for the benefit of all employees of the Land Bank; and

WHEREAS, the Finance Committee has had an opportunity to review expenditures and terms of the employee medical benefit plan;

NOW, THEREFORE, BE IT RESOLVED by the Albany County Land Bank Corporation that:

- 1. The Executive Director is hereby authorized and directed by this Board to execute and deliver an employee medical benefit plan to current and future employees.
- 2. This Resolution shall take effect and be in force immediately upon its adoption.

RESOLUTION TO HIRE AN EXECUTIVE DIRECTOR

WHEREAS, the hiring committee has made the recommendation to hire Adam Zaranko as the as Executive Director of the Land Bank because he possess the necessary skills to understand the duties and functions of the position and the Land Bank;

NOW, THEREFORE, BE IT RESOLVED by the Corporation that:

- 1. The Chairman and of the Land Bank is authorized and directed to make a formal offer of employment to Adam Zaranko;

RESOLUTION AUTHORIZING THE SALE OF MULTIPLE PARCELS OF REAL PROPERTY

WHEREAS, New York Not-For-Profit Corporation Law §1609(d) authorizes the Albany County Land Bank Corporation, Inc. ("Land Bank") to convey, exchange, sell, or transfer any of its interests in, upon or to real property; and

WHEREAS, New York Not-For-Profit Corporation Law §1605(i)(5) requires that a sale of real property be approved a majority vote of the Board of Directors; and

WHEREAS, Section 4(g) of the Land Bank's Disposition of Real and Personal Property (the "Property Disposition Policy") permits the Land bank to dispose of property for less than fair value by negotiation when the disposal is within the mission, purpose, or governing statute of the LAND BANK, subject to obtaining such competition as is feasible under the circumstances; and

WHEREAS, Section 4(f) of the Property Disposition Policy also permits the Land Bank to dispose of property by negotiation when the fair market value of the property does not exceed Fifteen Thousand Dollars (\$15,000.00), subject to obtaining such competition as is feasible under the circumstances; and

WHEREAS, all disposals of Land Bank property must be made to qualified buyers pursuant to Section 5 of the Property Disposition Policy; and

WHEREAS, the LAND BANK owns certain parcels of real property situate in the City of Albany, County of Albany, and State of New York and more particularly identified on the Properties List attached hereto as Schedule A (individually, a "Property" or collectively, the "Properties"); and

WHEREAS, each Property's appraised fair market value is set forth on the Properties List; and

WHEREAS, LAND BANK staff, after evaluating all purchase offers received for the Properties in accordance with the Property Disposition Policy, have recommended that the LAND BANK sell each Property to the corresponding Buyer identified on the Properties

List (individually, a "Buyer" or collectively, the "Buyers") in accordance with the terms and conditions set forth therein; and

WHEREAS, LAND BANK staff have determined that each Buyer is a qualified buyer; and

WHEREAS, the LAND BANK has obtained such competition as is feasible under the circumstances for each Property by advertising the Property on its website and/or listing the Property with a licensed real estate broker; and

WHEREAS, as each Buyer's plans are consistent with the mission, purpose and governing statute of the LAND BANK, the Property Disposition Policy permits the LAND BANK to sell each Property to the corresponding Buyer by negotiation; and

WHEREAS, if any Property is being disposed of for less than fair market value, the Board of Directors (the "Board") has considered the information set forth in Section4(g) of the Property Disposition Policy and has determined that there is no reasonable alternative to the proposed transfer that would achieve the same purpose of such transfer; and

WHEREAS, the LAND BANK desires to sell each Property to the corresponding Buyer identified on the Properties List at the price which was offered by each Buyer, as set forth on the Properties List; and

NOW, THEREFORE, BE IT RESOLVED BY THE ALBANY COUNTY LAND BANK CORPORATION AS FOLLOWS:

- 1. The recitals above are hereby incorporated into this Resolution as if fully set forth herein.
- 2. The Members of the Board hereby authorize the LAND BANK to sell each Property to the corresponding Buyer identified on the Properties List and authorize the Executive Director to enter into a Contract to Purchase with the LAND BANK as seller and the Buyer as buyer with respect to each Property. Each Contract to Purchase will be agreeable in form and content to the Executive Director and LAND BANK counsel.
- 3. The Chairman, Vice Chairman and the Executive Director of the LAND BANK are each hereby authorized and directed to execute all documents on behalf of the LAND BANK which may be necessary or desirable to further the intent of this Resolution and do such further things or perform such acts as may be necessary or convenient to implement the provisions of this Resolution.

- 4. The other officers, employees and agents of the LAND BANK are hereby authorized and directed for and in the name and on behalf of the LAND BANK to execute and deliver all such certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable andproper to effect the purposes of the foregoing Resolution.
 - 5. This Resolution shall take effect immediately.

RESOLUTION AUTHORIZING THE ACQUISITION OF MULTIPLE PARCELS OF REAL PROPERTY

WHEREAS, New York Not-For-Profit Corporation Law §1609(d) authorizes the Albany County Land Bank Corporation, Inc. ("Land Bank") to acquire real property by gift, devise, transfer, exchange, foreclosure, purchase, or otherwise; and

WHEREAS, pursuant to New York Not-For-Profit Corporation Law §1605(i)(5) the Land Bank may accept transfers of real property from municipalities upon such terms and conditions as agreed to by the Land Bank and the municipality; and

WHEREAS, the County of Albany holds title to certain tax foreclosed, abandoned, and vacant parcels of real property, the inventory of such properties are attached to this Resolution as Appendix "A"; and

WHEREAS, the properties are located in the target areas of the Land bank and the acquisition of these properties would be consistent with the Land Bank's purpose and mission; and

NOW, THEREFORE, BE IT RESOLVED BY THE ALBANY COUNTY LAND BANK CORPORATION AS FOLLOWS:

- 1. The Land Bank is hereby authorized to acquire title to various properties from the County of Albany, the inventory of such properties are attached to this Resolution as Appendix "A".
- 2. The Chairman and the Executive Director of the Land bank are each herby authorized and directed to execute all documents on behalf of the Land bank which may be necessary or desirable to further the intent of this Resolution and do such further things or perform such acts as may be necessary or convenient to implement the previsions of this Resolution.
- 3. This Resolution shall take effect immediately.

- 1. The Agreement for asbestos abatement Services to be performed by WPNT Construction, LLC, for the benefit of the Land Bank is awarded and approved; and
